- 1. Course registrations are only valid if a written registration has been made and after VieSID has issued a seat confirmation for this course.

- 5.1 Cancellations must be made in writing.
 5.2 Cancellation of a modular course by participants: In the event of cancellation 30 days before the start of the course or earlier, the registration fee and further course payments will be 100% refunded. In the event of cancellation 29 days or less before the start of the course, the registration fee will be withheld or charged. If the participants fail to show up, 50% of the total course fee will be charged.
- 5.3 Cancellation of a keynote, seminar or tutorial by participants: In the event of cancellation 30 days before the start or earlier, the course fees will be 100% refunded. If you cancel 29 days or less before the start, 20% of the total course fee will be charged. In the event of no-show, VieSID reserves the right to charge 50% of the total course fee.
